Lookup Table: Value added	OTN_PERMITTED_USE_LIST	New values added: Four Wheel Driving, Geocaching, Rock Climbing, Ice Climbing, In-line Skating. Some existing values changed to replace '/' with 'or'
Table: Added	OTN_OTC_TRAIL_CHARACTER	Created new child table for one or many trail character values.
Table: Added	OTN_TRAIL_ACCESS_POINT	New child table added to hold one or many access points for a trail head.
Table: Field added	OTC_TRAIL_CHARACTER	New attribute added to new OTC trail character table for OTC Trail Character Name
Table: Field added	TRAIL_GROUPING	New attribute added to OTN Trailhead for information on high level trail grouping.
Table: Field altered	LENGTH_KMS	Data type for Length Kms changed from NUMBER(4,1) to NUMBER(6,1)
Table: Field dropped	TRANS_CANADA_TRAIL_IND	Trans Canada Trail Indicator was moved from OTN Trailhead to OTN Trail Segment
Table: Field dropped	OTC_TRAIL_CHARACTER	Column removed from Trailhead Table

a) **Type:** Table Added; Table Changed; Data Dictionary; Geog Unit Type Change

b) **Target:** Identifies target of change – identify i) Table Name if added or dropped, ii) Table.Attributename if attribute is added, dropped or modified in a table, iii) Geog. Unit Type Name if a new Data Type is added/expired has description modified etc...

c) **Description:** Additional description of change type,; e.g.: 'Field length expanded from 40 to 80 chars'.
